AMENDED NOISE GUIDELINES FOR CRESTED BUTTE SOUTH SPECIAL AREA

Any previously adopted and approved Noise Guidelines for Crested Butte South shall be superseded and replaced in entirety with the following.

MAXIMUM PERMISSIBLE NOISE LEVELS

- I. Every permitted use in Crested Butte South Special Area to which this regulation is applicable shall be conducted in a manner so that any noise produced is not objectionable due to intermittence, beat frequency, or shrillness. Sound levels of noise radiating from a property line at a distance of 25 feet or more therefrom in excess of the db(A) established for the time periods and zones below shall be a violation, subjecting the property owner and/or user causing such excess noise to fines:

<u>ZONE</u>	<u>7:00 AM TO 7:00 PM</u>	<u>7:00 PM TO 7:00 AM</u>
RESIDENTIAL	55 db(A)	50 db(A)
COMMERCIAL/BUSINESS	60 db(A)	55 db(A)

- II. In the hours between 7:00 AM and the next 7:00 PM, the noise levels permitted above may be increased by ten (10) db(A) for a period not to exceed ten (10) minutes in any given one-hour period.
- III. Periodic, impulsive or shrill noises shall be a violation when such noise levels are at a sound level of 5 db(A) less than those listed above.
- IV. Construction projects shall be subject to the maximum permissible noise levels for identified for light industrial of 70 db(A) according to the permissible hours of construction for Crested Butte South.
- V. Measurements with sound level meters shall be made when the wind velocity, at the time and place of such measurement, is not more than five miles per hour.
- VI. The maximum permissible noise levels shall not be applicable to the use of Association property by Crested Butte South Property Owners' Association for the purpose of promoting, producing, or holding cultural, entertainment, athletic or patriotic events, including, but not limited to music festivals, concerts, and firework displays.
- VII. All applicable businesses shall comply with the Allowable Business Hours, adopted by the Board of Directors, on August 4, 2015 including amendments thereto.

ENFORCEMENT

Fines for violations of the permissible noise levels above shall be subject to the Association's policy on imposition of fines and hearing, and shall be as follows:

- First Violation: Warning
- Second Violation: \$100.00
- Third Violation \$200.00
- Fourth Violation: \$400.00

Additional violations will be assessed in additional \$200.00 increments.

Except that the following Fine Schedule shall apply to the CB South Business District (Commercial Area) where commercial/business properties exist.

- First Violation: \$200.00
- Second Violation: \$400.00
- Third Violation: \$800.00
- Fourth Violation: \$1,600.00

Additional violations for commercial zones will be assessed in additional \$400.00 increments. Owners who accumulate four (4) or more violations within a 12-month period shall be deemed habitual offenders and shall be subject to the fine for habitual offenders in addition to the fining schedule set forth herein.
