RESOLUTION DESIGNATING CRESTED BUTTE SOUTH
AS A DESIGNATED DOG CONTROL AREA

Resolution No. 1992-20

WHEREAS, pursuant to Section 30-15-101, C.R.S. 1973, as amended, on February 18, 1992 the Board of County Commissioners adopted Resolution No. 1992-10 providing for the control and licensing of dogs within specifically described designated dog control areas of Gunnison County; and

WHEREAS, Crested Butte South Property Owners Association, Inc., the homeowners association for Crested Butte South, Filings 1, 2, 3 and 4, Gunnison County, Colorado ("Crested Butte South") has requested that the Board of County Commissioners designate Crested Butte South and that part of County Road #740 contiguous to Crested Butte South a designated dog control area; and

WHEREAS, the Board of County Commissioners has caused to be publicized a hearing to consider the question of whether to designate Crested Butte South and that part of County Road #740 contiguous to Crested Butte South as a designated dog control area, and has requested comments from the residents of Crested Butte South; and

WHEREAS, on February 4, 1992, the Board of County Commissioners conducted a hearing to consider the written comments of residents of Crested Butte South as well as verbal testimony presented at this hearing; and

WHEREAS, after considering all of the written comments and testimony presented, the Board of County Commissioners finds that it is in the best interests of the public health, safety and welfare of the residents of Gunnison County that Crested Butte South and that part of County Road #740 contiguous to Crested Butte South be designated as a designated dog control area;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Gunnison County that Crested Butte South, Filings 1, 2, 3 and 4 and that part of County Road #740 contiguous to Crested Butte South, Gunnison County, Colorado are hereby designated as a designated dog control area under Resolution No. 1992-10 and that all of the terms and provisions of such Resolution No. 1992-10 shall apply to Crested Butte South, Filings 1, 2, 3 and 4 and that part of County Road #740 contiguous to Crested Butte South effective thirty days after adoption of this Resolution.

SEVERABILITY. If any provision of this Resolution or the application thereof to any party or circumstance shall to any extent be invalid or unenforceable, the remainder of the Resolution, or the application of such provision to parties or circumstance other than those to which it is invalid or unenforceable, shall not be affected thereby, and each provision of this Resolution shall be valid and be enforced to the fullest extent permitted by law.
